

SILK & SPICE



TASTING NOTE

Attractive citrus yellow and slightly golden in colour. Aromatically intense with notes of ripe peach, melon and white flowers, balanced with a touch of vanilla. The palate is well-rounded, with an excellent integration of American oak and a very long, balanced and agreeable finish.

GRAPE VARIETY

Arinto (35%); Alvarinho (15%); Bical (50%).

WINEMAKING

The grapes come from selected varieties from Bairrada and Lisbon (Bucelas). After destemming, the grapes were gently pressed and the must clarified by static decantation. The next stage was alcoholic fermentation in stainless steel vats at a controlled temperature. Alcoholic fermentation took place at temperatures between 15-17°C.

MATURATION

After alcoholic fermentation in stainless steel tanks, part of the wine was kept on fine lees.

SERVE

Serve directly from the original bottle. Recommended temperature: 8°C to 10°C. Drink within 24 hours of opening.

ENJOY

The perfect accompaniment to grilled vegetables, pasta with creamy sauce, sushi and grilled poultry.
